- 13. That the society shall submit proposals for renewal of provisional recognition sufficiently in advance i.e., at least (6) months prior to the date of expiry of the renewal.
- 14. That additional sections/higher classes should not be opened without prior permission of the competent authority.
- 15. That the recognition is accorded to society and no other society or body can open a school on their behalf.
- 16. The recognition is accorded to open the school premises in the locality and there shall not be any change in the premises or locality.
- 17. The society shall provide, the necessary material even if it costs more than the deposit amount.
- 18. Admissions should be made on the basis Record sheet issued by the Private Recognized/ZP/Govt/Aided schools only T.Cs/Certificates issued by the Secretary, DCEB as Bona-fied candidate.
- 19.The Edn.Society shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by Govt. from time to time by the end of April every year as per G.O.6<sup>th</sup> cited.
- 20. The above E.T.R. is granted subject to condition that, If it is found later that the school has not fulfilled the prerequisite condition under A.P.Edn. Act 1982, reported by State Level Inspection Team and Vigilance Committee, the E.T.R. now being granted is liable to be withdrawn at once.
- 21. The Management shall provide sufficient transportation, sufficient fire extinguishers in the school.
- 22. The Management is totally responsible in all aspects for the safety of school children. They will be personally held responsible if any incident occurs.
